3. EARNEST MONEY DEPOSIT (EMD)

Earnest Money Deposit of Rs. 2,000/- (Rupees two thousand only) in the form of a demand draft / pay order issued by a scheduled commercial bank favoring Union Bank of India, payable at Thiruvananthapuram must be submitted along with the offer. Bidders who are registered with National Small Scale Industries (NSIC) or vendors falling under the category of Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organisation or the concerned Ministry or Department and are exempted for EMD against submission of valid certificate/s. Offers not accompanied with Earnest Money Deposit will not be accepted. Bank Guarantee in lieu of Earnest Money Deposit will not be accepted. No interest will be payable on the Earnest Money Deposit. The Earnest Money Deposit will be refunded to the unsuccessful bidders. The Earnest money paid by the successful bidder will be released / adjusted against the sale consideration.

The Earnest Money Deposit will be forfeited if the bidder:-

- Withdraws their bid during bid validity period.
- Refuses to honor commercial bid.

4. BIDDING PROCESS - SINGLE STAGE

The response to the tender notice is to be submitted in the prescribed format placed at **ANNEXURE 1 & 2** of this tender notice. The validity of the bids for acceptance shall be 180 days.

5. SUBMISSION OF BIDS

Tender documents shall be signed wherever provided for and **on all pages** by the bidder / by the authorized signatory. **Tenders not so signed by the authorized signatory of the bidder shall be rejected.** The tenders shall be submitted in sealed cover to the office of "The Deputy General Manager, Union Bank of India, Regional Office, First Floor, Statue, M. G. Road, Thiruvananthapuram - 695 001" on all working days from 10.00 AM to 5.00 PM till 16/08/2026 and till 11.00 AM on the last date of receipt of tenders. The full name and postal address of the tenderer shall be written on the bottom left hand corner of the sealed cover. The sealed cover must be superscribed "Tender for sale of Cash Van". Bidders should drop their bids in the Tender Box at the above address latest by the last date & time for submission of offers.

6. OPENING OF BIDS, DETERMINATION OF H1 BIDDER

Bank will open commercial offers of successful bidders and the highest bidder shall be considered for sale of Cash van adhering to Bank's internal guidelines and procedures.

8. ERASURES OR ALTERATIONS

No submissions for erasures or alteration will be entertained after submission of tender document. If a vender submits two bids the highest rates will be considered provided both bids have all the documents as per the TENDER.

9. PAYMENT TERMS

The successful bidder is required to remit the amount offered to the Bank at the dedicated account which will be informed by the Bank to the successful bidder post finalization and approval.

10. PRICES

All prices should be quoted in INR (Indian Rupees) exclusive of taxes. Bank will not pay any type of taxes / insurance and it will be the liability of the bidder to pay all required mandatory taxes and insurances before the vehicle is taken out of the premises.

11. GOVERNING LAW AND DISPUTES

The provisions of this tender shall always be subject to government notifications, any rules/ guidelines that may be in force from time to time. All disputes or differences whatsoever arising between the parties out of or in relation to the construction, meaning and operation or effect of these Tender Documents or breach thereof shall be settled amicably.
